quarter lining: three-dimensional fabric art. "AT 488 SPECIAL" in col. black;

insole: white multi-layer perforation-resistant fabric art. LC/ZP01, which also has the function of penetration-resistant insert;

removable insock: grey foamed material matched with a black textile in contact with the foot, with an aluminum oval insert stitched with an antistatic zig-zag stitching to the forepart, plus an insert in red ABS in the heel;

toe-cap: polymeric material, art. "6050 GRISPORT".
